

“NEWCASTLE AIRPORT HOLIDAY GIVEAWAY 2021” PROMOTION

TERMS AND CONDITIONS

1. Information on how to enter and the prize form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. Entry is only open to NSW, VIC, and QLD residents aged 18 years or over.
3. Employees (and their immediate families) of the Promoter and agencies associated with this promotion are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.
4. Entries into the promotion open on 29 November 2021 and close at 11:59PM AEDT on 4 February 2022 (“**Promotional Period**”).
5. 6. Only one (1) entry is permitted per person.

The Promoter reserves the right, at any time, to verify the validity of entries and entrants (including an entrant’s identity, age and place of residence) and reserves the right, in its sole discretion, to disqualify any individual who the Promoter has reason to believe has breached any of these Terms and Conditions, tampered with the entry process or engaged in any unlawful or other improper misconduct calculated to jeopardise fair and proper conduct of the promotion. Errors and omissions may be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights. The Promoter's legal rights to recover damages or other compensation from such an offender are reserved.
8. Incomplete or indecipherable entries will be deemed invalid.
9. If there is a dispute as to the identity of an entrant, the Promoter reserves the right, in its sole discretion, to determine the identity of the entrant.
10. The draw will take place at Newcastle Airport, Level 1 (East), Terminal Building, Williamtown Drive, Williamtown NSW 2318 on 7 February 2022 at 10:30AM AEDT. The Promoter may draw additional reserve entries and record them in order in case an invalid entry or ineligible entrant is drawn. The winner will be notified by telephone and email within two (2) business days of the draw. The winner will be published at <https://www.newcastleairport.com.au/parking-transport/win-a-holiday> from 7 February, 2022.
11. The Promoter’s decision is final and no correspondence will be entered into.
12. The first valid entry drawn will win a credit up to the value of \$250 to spend on food and beverage from hospitality retailers in Newcastle Airport terminal; a credit of up to \$280 to spend at the Newcastle Airport car park; and a \$2,000 Travel Associates (Newcastle) travel voucher. The winner has the option to select their own destination

and travel dates, subject to flights and booking availability. The winner and their companion/s (if any) must arrive to and/or depart from Newcastle Airport. Credit for spending money at Newcastle Airport will be valid between the travel dates selected by the winner. The travel voucher must be used within 12 months of the prize draw.
